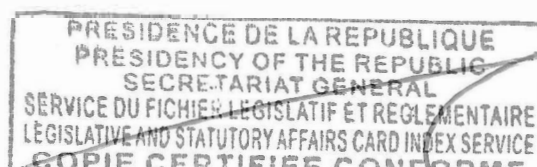

HEREBY DECREES AS FOLLOWS:

SECRETARIAT GENERAL

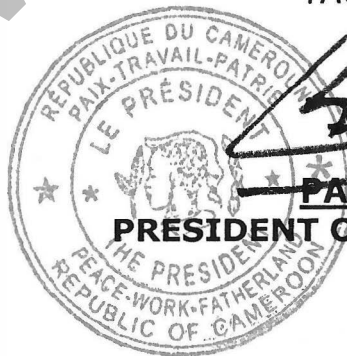
