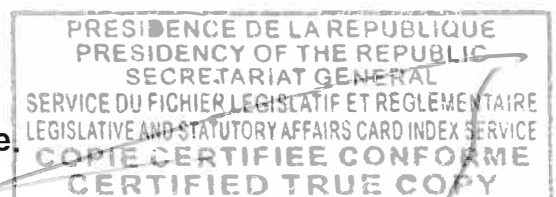
Mindful of Decree No. 2018/665 of 05 November 2018 to reorganize the National Institute of Cartography;

**Mr OLINGA Alain Didier.**



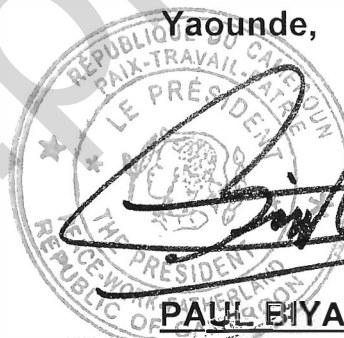
- Representative of the Ministry of Economy, Planning and Regional Development:
