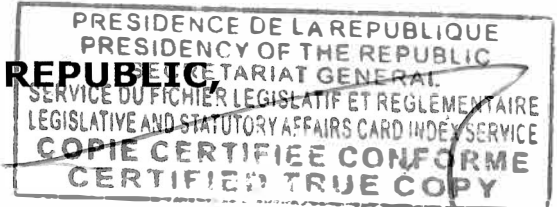


DECREE No. 2022/303 OF 14 JUIL 2022
to appoint Subdivisional Officers.-
