Cameroon Water Utilities Corporation (CAMWATER).-

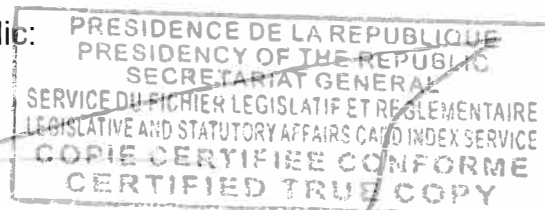
THE PRESIDENT OF THE REPUBLIC,

- Mindful of Decree No. 2011/408 of 9 December 2011 to organize the Government, as amended and supplemented by Decree No.2018/190 of 2 March 2018;
- Mindful of Decree No. 2018/144 of 20 February 2018 to reorganize the Cameroon Water Utilities Corporation;

HEREBY DECREES AS FOLLOWS:
