to appoint members of the Board of Directors of the

THE PRESIDENT OF THE REPUBLIC,

- Mindful of Decree No. 74/182 of 8 March 1974 to establish and organize the Livestock Development Corporation, and subsequent amendments thereto;
- Mindful of Decree No. 2011/408 of 9 December 2011 to organize the Government, as amended and supplemented by Decree No. 2018/190 of 2 March 2018;
- Mindful of Decree No. 2019/320 of 19 June 2019 to lay down conditions for implementing some provisions of Law No. 2017/010 and Law No. 2017/011 of 12 July 2017 to lay down the general rules and regulations governing public establishments and public corporations;
- Mindful of Decree No. 2021/091 of 12 February 2021 to transform the Livestock Development Corporation into a State-owned Corporation;
- Mindful of Decree No. 2021/092 of 12 February 2021 to approve the articles of association of the Livestock Development Corporation,

HEREBY DECREES AS FOLLOWS:

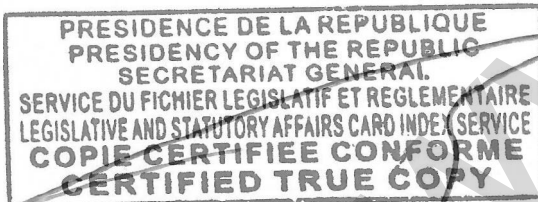

Mr KONGAPE Jean Avit.

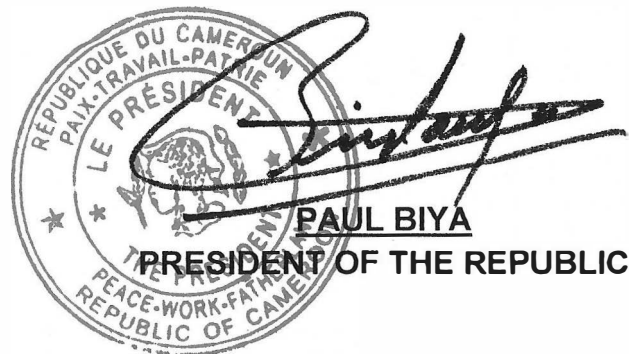
- Representative of the Ministry of Livestock, Fisheries and Animal Industries:
