**HEREBY DECREES AS FOLLOWS:**

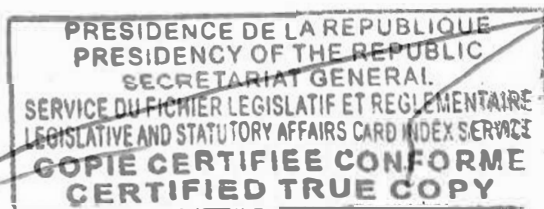

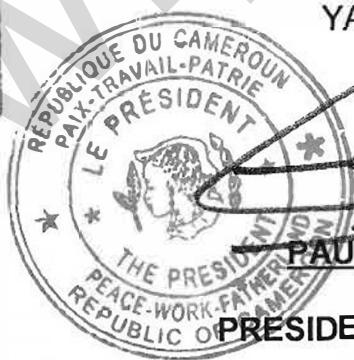
