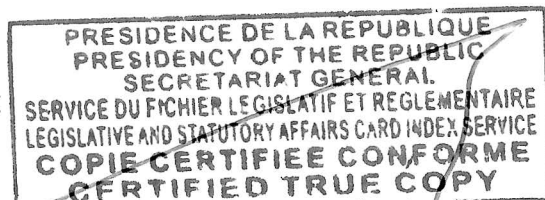
Mindful of Decree No. 2019/075 of 18 February 2019 to reorganize the Institute of Agricultural Research for Development;

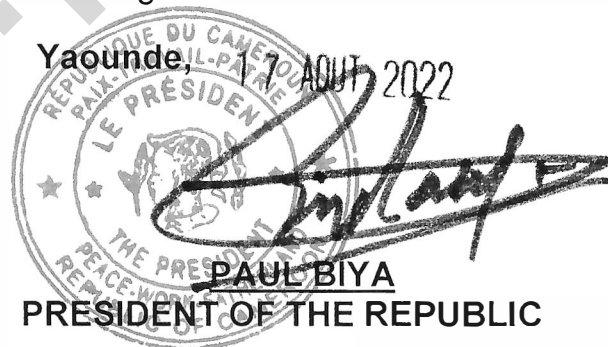
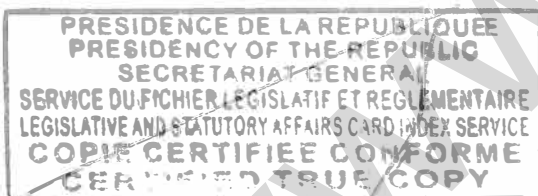
