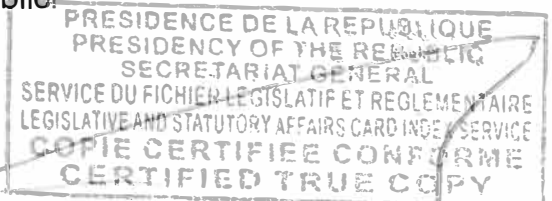
Mindful of Decree No. 2018/354 of 7 June 2018 to lay down the reorganization and functioning of the National Social Insurance Fund;


