to organize the Cabinet of the President of the

Economic and Social Council

THE PRESIDENT OF THE REPUBLIC,

Mindful of the Constitution;

Mindful of Law No. 2017/9 of 12 July 2017 to lay down the powers, organization and functioning of the Economic and Social Council,

HEREBY DECREES AS FOLLOWS:

<u>ARTICLE 1</u>: This decree lays down the organization of the Cabinet of the President of the Economic and Social Council.

<u>ARTICLE 2</u>: The Cabinet of the President of the Economic and Social Council shall comprise:

- two Technical Advisers;
- two Chargés de Mission;
- a Chief of Cabinet;
- a Private Secretariat;
- a Protocol Office.

<u>ARTICLE 3</u>: (1) The Technical Advisers and Chargés de Mission shall discharge all duties assigned to them by the President of the Economic and Social Council.

(2) The Technical Advisers may receive delegation of signature.

ARTICLE 4: The Chief of Cabinet shall be responsible for:

- supervising the activities of the Protocol Office;
- the upkeep and running of the private residence of the President of the Economic and Social Council.

ARTICLE 5: Under the authority of a Private Secretary, the Private Secretariat shall be responsible for the private matters of the President of the Economic and Social Council.

ARTICLE 6: Under the authority of a Bureau Head, the Protocol Office shall be responsible for:

- the President's mission and travel formalities, as well as official ceremonies and

decorations within the Economic and Social Council;

- receptions and audiences of the President of the Economic and Social Council.

ARTICLE 7: Officials of the Cabinet shall be appointed by the President of the Economic and Social Council.

<u>ARTICLE 8</u>: The remuneration and benefits of Council officials and staff shall be fixed by decree of the President of the Republic.

<u>ARTICLE 9</u>: Officials of the Economic and Social Council shall have the following ranks and prerogatives:

- Central administration director:

Technical Advisers;

- Central administration deputy director:

Chargés de Mission;

Central administration sub-director:
 Chief of Cabinet;

Central administration service head:
 Private Secretary;

Head of the Protocol Office:
 Bureau head.

ARTICLE 10: All previous provisions repugnant hereto, in particular those of Decree No. 86/1406 of 22 November 1986 to organize the Cabinet of the President of the Economic and Social Council are hereby repealed.

<u>ARTICLE 11</u>: This decree shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French.
