

DECREE No. 2021/724 OF 14 DEC 2021

to order the publication in the Official Gazette of the respective texts of Loan Agreement No. 6216-CM, for an amount of USD 45 million or approximately CFAF 25 billion, and Grant Agreement No. D2910 – CM for an amount of USD 52.45 million or approximately CFAF 29.3 billion, concluded on 19 August 2021 between the Republic of Cameroon and the International Development Association (IDA), as additional financing for the Cameroon Education Reform Support Programme (CERSP)

THE PRESIDENT OF THE REPUBLIC,

Mindful of the Constitution;

Mindful of Ordinance No.72/11 of 26 August 1972 relating to the publication of laws, ordinances, decrees and statutory instruments;

Mindful of Law No. 2020/18 of 17 December 2020: Finance Law of the Republic of Cameroon for the 2021 financial year;

Mindful of Law No. 2021/10 of 21 June 2021 to ratify Ordinance No. 2021/2 of 26 May 2021 to amend and supplement some provisions of Law No. 2020/18 of 17 December 2020: Finance Law of the Republic of Cameroon for the 2021 financial year;

Mindful of Law No. 2021/16 of 9 July 2021 to ratify Ordinance No. 2021/3 of 7 June 2021 to amend and supplement some provisions of Law No. 2020/18 of 17 December 2020: Finance Law of the Republic of Cameroon for the 2021 financial year;

Mindful of Decree No. 77/4 of 6 January 1977 to regulate the publication of documents in the Official Gazette of the United Republic of Cameroon;

Mindful of Decree No. 2021/427 of 18 August 2021 to authorize the Minister of Economy, Planning and Regional Development to sign with the International Development Association (IDA), the respective agreements for a loan of an amount of USD 45 million, or approximately CFAF 25 billion, and a grant of an amount of USD 52.45 million, or approximately CFAF 29.3 billion, as additional financing for the Cameroon Education Reform Support Programme (CERSP),

HEREBY DECREES AS FOLLOWS:

ARTICLE 1: The publication in the Official Gazette of the respective texts of the Loan Agreement for an amount of USD 45 million, or approximately CFAF 25 billion, and the Grant Agreement for an amount of USD 52.45 million, or approximately CFAF 29.3 billion, concluded on 19 August 2021 between the Republic of Cameroon and the International Development Association (IDA), as additional financing for the Cameroon Education Reform Support Programme (CERSP) is ordered.

ARTICLE 2: This decree shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French.
